Sealed bids will be received by the Board of County Commissioners of Perry County, Ohio, at the Office of the County Commissioners, 212 South Main Street, New Lexington, Ohio 43764, until 9:30 AM, April 6, 2022, for the purchase of various sizes of crushed limestone aggregate which may be required by the Perry County Engineer's Department for fiscal year 2022.

The graded aggregate shall conform to the various sizes specified in Items 703.01 and 703.04 and Table 703-1 of the Construction and Material Specifications of the State of Ohio, Department of Transportation dated January 1, 2005.

Bids to be submitted as follows:

Price per ton for No.'s 67, 57, 7, 8, 9, 4, 2, 411, 601,617, 304, sand and grits (or screenings), cold mix and hot mix, F.O.B., at Vendor's Plant, loaded on County trucks by Vendor.

Bids shall be filed on the proposal form furnished by the County and may be obtained from the County Commissioners, 212 South Main Street, New Lexington, Ohio 43764, or the Perry County Engineer's Department, 2645 Old Somerset Rd., New Lexington, Ohio 43764, during regular business hours.

The Bidder is hereby advised that the County does not guarantee the actual quantities or various sizes of crushed limestone which may be purchased during the bid period. Each successful bidder shall, if his bid is accepted, be required to furnish all of the actual requirements as ordered during the bid period and at the bid price.

Bids shall be filed in the Office of the Perry County Commissioners, 212 South Main Street, New Lexington, OH 43764, in sealed envelopes, plainly marked "2022 AGGREGATE BID" on or before the time specified.

The Perry County Engineer and Board of Commissioners reserve the following rights which it deems to be in the best interest of the County:

1. The right to reject any and all bids or portions thereof.
2. The right to award contracts on an item by item basis.
3. The right to waive any technicality or informality.
