NOTICE TO BIDDERS

Prequalification

Bidders must be prequalified with the Ohio Department of Transportation's Office of Contracts, Contractor Qualifications Section, at least 90 days before the date set to open bids, also including sub-contractors.

Certificate of Compliance with Affirmative Action Programs

No contract shall be entered into unless the bidder possesses a valid Certificate of Compliance with Affirmative Action Programs, issued by the State EEO Coordinator, Certification Section, 77 South High Street, 24th Floor, Columbus, OH 43215, dated no earlier than 180 days prior to the date set for the opening of bids.

PREPARATION OF PROPOSAL

The blank spaces in the proposal must be filled in correctly, where indicated, and typed or written in black ink.

The bidder is required to enter a unit price bid in the "Unit Cost" column and to multiply the unit price bid times the quantity set forth for that "Item No." and to then enter the result in the "Total Cost" column. The bidder is further required to enter a lump sum bid in the "Total Cost" column for each "Item No." which requires a "Lump Sum Bid". The bidder shall then add all of the figures in the "Total Cost" column (exclusive of individual section sub-totals) and enter the sum in the space provided for the "PROJECT TOTAL".

Failure by a bidder to enter a unit price or lump sum price for each item set forth in the bid proposal will render the bid non-responsive at the discretion of the Perry County Engineer (hereafter referred to as Engineer).

The "TOTAL AMOUNT OF THE BID" set forth on the "Unit Price Contract" page is only for the convenience of the Engineer in reading bids. The unit prices and lump sum prices entered in the "Unit Price Bid" column will normally govern the award of the contract unless the Engineer determines from the face of the bid that the bidder had a different unit or lump sum price intent.

Investigation:

The Engineer may conduct such investigations as he deems necessary in order to assist in the evaluation of any bid.

Bid Guaranty - (Payable to the Perry County Commissioners):

Each bidder is required to file with his bid a certified check or cashier's check for an amount equal to five percent of his bid, but in no event more than fifty thousand dollars, or a bid bond for ten percent of his bid payable to the Perry County Commissioners.

Construction Bonds & Insurance of Contractor:

The successful bidder must furnish a performance bond and a payment bond in an amount equal to one hundred percent (100%) of the contract price. (Sec. 5525.16 O.R.C.)

The successful bidder and each subcontractor shall maintain during the life of its contract and subcontract, Workers' Compensation Insurance, Public Liability with minimum coverage amounts of \$1,000,000 per occurrence, Property Damage with minimum coverage amounts of \$1,000,000 per occurrence, and Vehicle Liability Insurance.

Date set for completion: 90 days after notice to proceed.

Liquidated damages will be assessed as per ODOT 108.07.

UNIT PRICE: The unit prices for items 448 are price per cubic yard.

TRAFFIC: It shall be the responsibility of the contractor to maintain traffic in accordance with the Ohio Manual of Uniform Traffic Control Devices. At no time shall flaggers perform other duties while working on this project.

TESTING: The contractor shall submit test results for items 448 at the request of the Perry County Engineer. These tests shall provide Bitumen extractions and gradations.

Item 405 Bituminous Cold Mix and shall meet 1997 Ohio Department of Transportation Materials and Specifications Manual

Item 407 Tack - Payment for 407 Tack shall be included in your Item 448 Asphalt Intermediate Course at a rate not less than .075 Gals. /S.Y.

Item 617 Berm - A quantity of 617 has been included in the project for placement along the hot mix roads at the direction of the Perry County Engineer. Approximate Quantity - County Roads 450 tons, Hopewell township road 22 tons.

Item 448 Material and Work Specifications - All materials and work shall be in conformance with the 2010 edition of the State of Ohio, Department of Transportation Construction and Materials Specifications.

Item 254 Pavement in Villages of Thornville and Crooksville shall consist of planing 1 ½" at curb and taper to 0" at 7 feet.

NOTE 1: Manhole risers, catch basins, and utility valves shall be placed as part of this bid by the contractor and installed as directed by the Village. The necessary items (risers) shall be provided by the Village.

NOTE 2: The quantity of manholes and water valves should be field verified by the contractor prior to bidding.

NOTE 3: Asphalt Grindings shall be delivered to an approved location in the village.
